Powersaw Tree Felling. Sign-up for this event at “Check In.” **You must be present to sign up.** Entry fee is \$5 cash. 20 positions are available. Priority will be granted to those who participated in this event the prior year. Vacant spots will be filled at the contestants meeting from the remaining pool of contestants.

Chopping Events. White pine. **Entries may be limited based on available wood. Get your entries in early!** You must choose “Intermediate” or “Open” for the underhand chop (not both). Underhand Chop is limited to the first 24 total entries received. Springboard is limited to the first 15 entries received. We are asking for a \$5 cash donation per entry (paid on day of show) to cover lathe turning of chopping blocks.

Sawing Events. Cottonwood or white pine. Powersaw bucking will be “Cold Start.” Saws will be provided for Ma & Pa Bucking. Contestants should provide their own saw for Single Bucking. Please specify if you are sharing a saw with another contestant.

Sign up for **Wrapper Throwing** and **Trailer Backing** on the day of the event. **Unlimited Hotsaw** will be exhibition only.
