HOLD HARMLESS AGREEMENT WAIVER and FULL RELEASE OF LIABILITY

I, the Undersigned agree to adhere at all times to all rules, regulations and policies of the Sequim Irrigation Festival and to follow all directions and instructions of its officials, including its Security Personnel. The undersigned hereby releases the Sequim Irrigation Festival Committee of any care, custody or control against loss, theft, vandalism and/or fire during this event on May 13, 2017.

I, the Undersigned do hereby agree to release, relieve, discharge, indemnify, defend and hold harmless the Sequim Irrigation Festival staff, all Sequim Irrigation Festival participants, the City of Sequim and the Sequim Dungeness Valley Chamber of Commerce, and their officers, agents, volunteers and employees, from all claims, losses, suits, damages, judgments, expenses, costs and charges of every kind to myself or my vehicle, including court costs and attorney's fees, herein under contract by reason of personal injuries, death or property damages. I, the Undersigned further agrees to indemnify, defend and hold harmless the Sequim Irrigation Festival staff, all Sequim Irrigation Festival participants, the City of Sequim and the Sequim Dungeness Valley Chamber of Commerce, and their officers, agents, volunteers and employees, from any claims and for all damages, costs and expenses, including without limitation, court costs and attorney's fees and amounts paid in settlement incurred in connection with such claims arising out of acts of negligence of undersigned, his agents or employees. This paragraph shall survive termination of this Agreement.

I, the Undersigned fully understand that the terms of the Full Release shall serve as a Full Release and Full Assumption of risks for myself, my heirs, executors and administrators and for all persons authorized by me accompanying me to the Event.

I, the Undersigned hereby attests and verifies that I am Lawfully Licensed to operate a motor vehicle in the State of Washington (or the State I reside in), and I possess Liability Insurance to cover bodily injury or property damage that might arise from either my participation in the Event or in participation of those authorized by me to so participate in the Event. I am aware of the risks involved in the participation in the Event, and fully assume such risks for myself, my vehicle(s) and my authorized representatives.
